Paving the way for a Future without Animal Testing: EPAA 20th Anniversary

5th November 2025 - European Parliament, Brussels

Twenty years ago, the European Partnership on Alternative Approaches to Animal Testing (EPAA) began as a ‘bold experiment’ – a Commission-industry partnership focussed on replacing animal testing with innovative, science-based alternatives.

Today, it became a European success story: proof that we can align innovation, industrial competitiveness, and ethical responsibility. EPAA has shown that regulatory ambition and industrial innovation can be complementary. They can reinforce each other. By building trust across sectors, fostering scientific excellence, and championing the 3Rs – the principle of replacement, reduction, and refinement of animal use in testing – EPAA has helped bring animal-free methods into the regulatory mainstream.

This is evident in chemical safety assessments and in one of Europe’s proudest achievements: the complete ban on animal testing for cosmetics, which has inspired action worldwide. As we implement the European Commission’s roadmap to phase out animal testing for chemical safety assessments, the EPAA’s experience will be indispensable. EPAA has created not only a knowledge base but a community – one capable of delivering smarter, safer, and more sustainable solutions for Europe.

Insights from EPAA Anniversary event

Today we congregated within the European Parliament in an event hosted by MEP Tilly Metz and opened by the President of the European Parliament, Roberta Metsola to recognise EPAA's contribution to ending animal testing through advancing regulatory use of animal-free methods over the last twenty years. Two forward looking panel discussions took place with EPAA members and partners from policy, industry, regulators and stakeholders. The first panel discussion, chaired by MEP Tilly Metz, gave insights on policy aspects on achieving the goal of replacing, reducing or refining animal testing, new policy initiatives and the role EPAA can play in supporting them. The second panel discussion, chaired by MEP Sirpa Pietikäinen, outlined how to strengthen regulatory acceptance of animal-free methods and how EPAA can help in the implementation of the upcoming Commission's roadmap to phase out animal testing for chemical safety assessments as well as in progressing a Test Method Development and Validation Strategy.
